GENERAL INFORMATION

- 1.S. Bhambri & Associates will be hosting the First Trial Advocacy Tournament, 2021
- 2.The First Trial Advocacy Tournament, 2021 will commence from 29th May, 2021 to 30th May, 2021
- 3.The **venue** for the tournament is **Google Meet**
- 4.The Competition shall be open for students who are pursuing LL.M. Programme or integrated 5 year LL.B. Programme or 3 year LL.B. Programme from any Institute/University in India. Such Institute/University must be recognized by the Bar Council of India.

LANGUAGE

- 1.The competition shall be organized and conducted in English language.

TEAM COMPOSITION

- 1.The maximum number of participants per team shall be 2. A team can also consist of an individual participant.
- 2.Each team will be provided with a unique team code. The identity of the teams shall not be disclosed at any stage, such disclosure shall invite penalties including disqualification.



DRESS CODE:

1. Participants should be appropriately attired in Black and White formals for the rounds of the competition

REGISTRATION:

1. The teams must register **online** at https://docs.google.com/forms/d/e/1FAIpQLSfcBieXYoQeO8vZP9cwzo3Lp4s3eijiwwbGPTZ9Hf32f4lk1Q/viewform?usp=sf_link by **24/05/2021**.
2. Participants after registrations will receive an acknowledgement cum approval as confirmation of their online registration & participation.
3. Once online registration is done no change in names will be possible

ORAL SUBMISSION RULES:

1. During the oral rounds teams would not be allowed to use any electronic devices.
2. No passing of chits shall be allowed during the rounds.
3. Each selected team shall be examining for the prosecution or for the defense.

FLOW OF ROUNDS :

1. There will be two rounds in the competition:
 - i) Prelims
 - ii) Finals

STRUCTURE OF COMPETITION:

1. Structure of the competition
2. prelims - 8 minutes per team
3. finals - 12 minutes per team
4. The division of time per speaker for a team is left at the discretion of the team members subject to time division mentioned above per speaker however the time limit for one speaker should not exceed the half to the total time allotted.
5. Strict adherence to court manners shall be observed by all the participants.
6. The video of the participants should be switched on during the competition.
7. The participants are advised to have a good internet connectivity any glitches will not be considered by the organizing committee however the final decision lies in the judge's discretion

EVALUATION & CRITERIA:

1. Knowledge of facts.
2. Logic, reasoning, clarity and systematic analysis of the issues arising out of facts.
3. Articulation, persuasiveness & deference to court.
4. Adherence to trial procedures and rules.
5. Ingenuity & innovate ability to argue by analogy.
6. General Impression.

SCOUTING RULES:

1. Teams are not allowed to observe the Oral Rounds of any other team.
2. Any incident of Scouting may result in immediate disqualification of the team from the Competition



ANONYMITY:

1. The identity of the team [name of the Law College / School / University] must not be disclosed to the Judges as well as to the other Participating Teams. Any such disclosure shall lead to disqualification
2. Teams must take special care while referring to written material, as the same should not indicate any reference to their institution.
3. Non-Compliance with this rule may result in immediate disqualification of the team.
